Medicaid Redesign Efforts Yielding Measurable Reductions in Avoidable Hospital Use

The New York State Department of Health recently announced that through the Medicaid Accelerated eXchange (MAX) Series, avoidable hospital use for the state's most vulnerable patients has been significantly reduced.

The objective of the MAX Series, launched in 2015, is to empower hospital and community partners in their care redesign efforts, increase patient and workforce satisfaction and reduce avoidable hospitalizations.

More than 900 professionals from 68 hospitals and 11 community-based practices from around the state, including the AHI PPS, have participated in the series to date and early results among teams are showing an 18-percent reduction in hospital readmissions and an eight-percent reduction in hospitalizations overall.

Actively Engaged Update

For DSRIP Years 4 and 5, AHI will be collecting actively engaged-related data for Projects [3.a.i](#) (Integration of Primary Care and Behavioral Health Services) and [3.g.i](#) (Integration of Palliative

Care into the Patient-Centered Medical Home Model) at the end of quarters two and four. A reminder email will be sent to project participants during the final month of those quarters.

For those involved in Project 3.a.i, the metric stating that at least 90 percent of patients receive preventive care screening, including behavioral health screening (PHQ-2 or 9 for those screening positive, SBIRT), at an established project site, is the last one we need to reach to complete milestone 3.
