### HealthyADK Website Adds Helpful New Features

<u>HealthyADK</u>, a website of key socio-economic indicators created to help improve community health and well-being maintained by Adirondack Health Institute, has added a number of helpful new features. The site now offers more than 500 searchable indicators and metrics, more than double the number previously available, and has expanded its reach from seven to nine counties. In addition, visitors can now access regional community health reports, assessments, and plans, along with evidence-based community health resources.

### Third and Final Installment of DY4 P4P **Funds Flow Released to PPS Partners**

The AHI PPS is pleased to announce the third and final distribution of DSRIP Year 4 funds flow to partner organizations. The third distribution will total \$1.4 million, bringing the total DY4 Funds Flow distribution to partners to \$17.9 million. Payments for the final distribution were mailed to eligible partners earlier this week.



As a reminder, to be considered in P4P calculations and receive a payment, a partner must have both returned financial sustainability documents, and be considered a safety-net partner based on the New York State Department of Health (NYS DOH) DSRIP reporting tool.

As with prior P4P funding methodology, a component of a partners' P4P payment will include determinations made by Population Health Network (PHN) Triad leaders in a PHN-level pool. The PHN-level pool payment will be made separately from the partner-level pool to those partners who were allocated a payment.

Dr. John Rugge, <u>Hudson Headwaters Health Network</u> founder and 46-year practicing physician, recently penned a letter to his patients announcing he will be starting the next phase in his transition from full-time work by stepping back from clinical practice at the end of October. "I can't bring myself to say retirement," said Dr. Rugge. "I hope you can imagine how much all the caring for so many wonderful people—including you!—has meant to me over the years and through the decades. Likewise, I hope you know how proud I am that Hudson Headwaters is making sure that you will be able to receive the health care you need in the years to come."
