Adirondack Health, Trudeau Institute Unveil High-Speed COVID-19 Test Lab

Adirondack Health and the biomedical research firm, Trudeau Institute, have teamed up to launch a new high-speed COVID-19 testing lab in Saranac Lake. The lab, which opened on October 23, is the first of its kind in the region. The creation of this new lab — which currently has the capacity to process anywhere from 80 to 160 tests per day — means faster turnaround times for COVID-19 test results.

GFH Receives Primary Stroke Center Certification



Glens Falls Hospital (GFH) recently announced it has received certification from <u>DNV GL Healthcare</u> as a Primary Stroke Center, affirming the hospital's readiness to handle a full range of stroke-related medical problems.

"This certification let's our community know we have the resources and commitment to provide the best possible stroke care," said Cassandra Moore, GFH Director of Neurology and Stroke Program. "It's a combination of the right equipment,

personnel and training to quickly assess and treat strokes. This includes the ability to efficiently transfer patients in the rare instances they require treatment beyond our capabilities. Achieving certification validates all the effort we have put into this program and to ensuring the health and safety of our patients."

The DNV GL Healthcare Primary Stroke Center Certification is based on standards set forth by the Brain Attack Coalition and the American Stroke Association and affirms that the hospital addresses the full spectrum of stroke care – diagnosis, treatment, rehabilitation and education – and establishes clear metrics to evaluate outcomes.
