AHI's Children's Health Home Expands Into Saratoga County

The <u>New York State Department of</u> <u>Health (NYSDOH)</u> has approved Adirondack Health Institute's expansion of Children's Health Home

services into Saratoga County. Previously, the organization was approved to serve only adults in the county. Health Home Children's providers can now enroll and accept referrals through the AHI Health Home Care Management program in the county.

AHI is a New York State-designated lead Health Home that serves all ages. Health Home Care Managers oversee and coordinate access to services to assist in meeting Medicaid-eligible individual's needs to help them stay healthy.

Glens Falls Hospital Receives Magnet Recognition

The Commission on Magnet Recognition earlier this week unanimously voted to credential <u>Glens Falls Hospital (GFH)</u> a Magnet Organization. GFH is one of only eight percent of all hospitals in the United States and less than 10 percent of hospitals world-wide to currently hold this distinction.

To receive this gold standard in nursing excellence recognition from the <u>American Nurses Credentialing</u> <u>Center (ANCC)</u>, an organization must demonstrate excellent quality outcomes, satisfied patients, and engaged nurses.


Glens Falls Hospital began its Magnet journey in 2013. Over the next seven years, the nurses at GFH formalized a structure of shared leadership, evidence-based practice, continuous quality improvement, and nursing research. After submitting a 700+ page document last year showcasing evidence to prove its world-class outcomes, three appraisers spent three days in February of this year observing each nursing area and meeting with hundreds of staff members to verify, clarify, and amplify what was written in the document.

The final step occurred as GFH announced at a live event on Tuesday of this week they had successfully completed the Magnet journey. During the announcement, the Commission notified the hospital that seven of their document sources of evidence were cited as industry exemplars.

Prepared4ALL Initiative Announces Launch of Online Training



The Prepared4ALL initiative, offered by the Association of University Centers on Disabilities' new Technical Assistance and Training Center on Disability Inclusion in Emergency Preparedness, recently announced the launch of an online training, *Prepared4ALL: Whole Community Inclusive Emergency Planning*. This free self-paced online training aims to help disability organizations increase their knowledge about emergency planning so they can begin or continue to get involved in these efforts in their local community while also building sustainable partnerships with their local emergency and public health professionals. This training is centered around the Prepared4ALL process, a strength-based model which helps organizations creatively and flexibly navigate inclusion and accessibility issues.
