
# 2023 Year in Review



Fort Drum Regional Health Planning Organization (FDRHPO) began a collaboration with the Adirondack Health Institute (AHI) to form the North Country Telehealth
 Partnership (NCTP) in 2015 — a unified effort to plan and implement telemedicine throughout 11-counties covering northern New York. This collaborative has quickly become northern New York's leading agency focused on increasing access to healthcare through the innovative use of telehealth and telemedicine technology.

### The Partnership works to increase access to healthcare via telehealth, through the following initiatives:

- Hosting the bi-monthly telehealth learning collaborative
- Fiber-optic network connecting healthcare facilities in the region
- Monitoring State and Federal telehealth policies
- Providing educational opportunities and technical assistance
- Promotion of telehealth, digital equity, and literacy
- Tracking telehealth utilization and addressing barriers to telehealth sustainability



# **2023 North Country Telehealth Data Overview**



Since 2020, telehealth encounters have increased dramatically as a result of the COVID-19 pandemic.

Telehealth continues to serve as a valuable tool for the region, reducing wait times, increasing access to specialty services, and providing convenience for community members who may face barriers to care such as transportation.







# **Regional Telemedicine Fiber Networks**

In 2009, FDRHPO created the North Country Telemedicine Project (NCTP), an extensive fiber-optic network that connected more than 25 healthcare facilities in Jefferson, Lewis, Oneida, Onondaga, and St. Lawrence counties, including Fort Drum's Guthrie Ambulatory Health Care Clinic. This network expanded in 2011, when FDRHPO partnered with the Adirondack-Champlain Telemedicine Information Network (ACTION) to create a second network encompassing sites in Clinton, Essex, Franklin, Rensselaer, Saratoga, Warren, and Washington counties, and Chittenden County in Vermont. Both networks now support over 75 healthcare facilities.



## **2023 North Country Leadership Summit**

September 27-28, 2023 Lake George, NY

Over 180 attendees from more than 90 organizations participated in the two-day conference and heard from 40 speakers from across the North Country and beyond. A sample of sessions included: NYS Telehealth Regulation Updates, Strategies to Increase Access to Care in Rural Communities, and Telehealth for EMS Response.

# **Digital Equity Efforts in the North Country**

In 2022, the North Country Telehealth Partnership received a grant through the NY Digital Inclusion Fund, which supported the creation of the North Country Digital Inclusion Coalition. This group of regional stakeholders was formed to address digital equity challenges and barriers to telehealth access and in the North Country. More than 30 regional stakeholders including broadband experts, healthcare professionals, library staff, and more, have joined the Coalition. As a result of this convening, new opportunities to support the work of the <u>NYS</u> <u>ConnectALL Office</u> have emerged. In 2023, the Coalition was invited to lead stakeholder engagement opportunities to collect data on digital inclusion strengths and barriers to support the creation of a NYS Digital Equity Plan. Regional data collected by the North Country Telehealth Partnership and the North Country Digital Inclusion Coalition have helped inform regional snapshots which can be found <u>here</u>.
